### **FOREWORD**

The amateur sports association SIENARUNNERS in cooperation with the Polisportiva Castiglione d'Orcia organises the 2nd edition of 'IL CAMMINO TUSCANY CROSSING'.

This is a non-competitive walk on routes of 14 km and 53 km.

Event under the patronage of the Municipality of Castiglione d'Orcia. With the collaboration of voluntary and public assistance associations in the Val d'Orcia.

The event is part of the recreational motor activity, as stipulated in Regional Law No. 35 of 09/07/2003, paragraphs 4 and 5.

### **.HOW TO REGISTER**

From 1 June 2022 it will be possible to register online until the end of available places.

The age

limit is set at 12 years of age accompanied by parents for the 14 km distance and 18 years of age for the 54 km

### **CLOSING OF REGISTRATIONS**

Registrations online and at the pre-sale points will be closed once the maximum number of 200 registrations for the 14 km and 300 registrations for the 54 km has been reached.

### **CERTIFICATIONS**

Due to the particular commitment required, the participant in the 54 km walk must enclose a medical certificate attesting to his or her state of good health (certificate of fitness for non-competitive sports). The certificate, which is valid on the date of the event, must be uploaded to the portal by the individual participant in the private area. In addition to the certificate of fitness for non-competitive sporting activity, certificates of fitness at a higher level are also valid.

Participants must be in perfect health and psychophysical shape to cope with the length of the course; any particular pathologies must be formally communicated, by email, to the organisation at the time of registration.

The organisation certifies that civil liability insurance is in place for the entire period of the event through a Uisp convention, however for each non-member participant the organisation will assume the burden of the temporary daily insurance cover.

### **GENERAL RULES**

It is permitted to bring dogs as long as they are kept on a leash and under the responsibility of the registered participant.

Running is prohibited, under pain of exclusion from the event with the withdrawal of the bib by the personnel in charge.

It is forbidden to start before the official start of the event as safety on the course would not be guaranteed and, in the event of transgression, the organisation reserves the right to withdraw the bib number.

### **PHOTOGRAPHS AND IMAGE RIGHTS**

## **DECLARATION OF LIABILITY**

The duly registered participant declares that he/she knows and respects the regulations of " IL CAMMINO TUSCANY CROSSING " published on the website [www.ilcamminodellavaldorcia.it](http://www.ilcamminodellavaldorcia.it) and on the website [www.tuscanycrossing.com](http://www.tuscanycrossing.com), he/she is aware that taking part in " IL CAMMINO TUSCANY CROSSING " and/or sporting events in general is potentially a risky activity. Furthermore, he/she declares that he/she voluntarily registers and assumes all risks arising from participation in the event: falls, contact with vehicles, with other participants, spectators or others, weather conditions, including scorching heat, extreme cold and/or wet weather, traffic and road conditions, all of which are well known and assessed. Being aware of the above, by accepting the entry, the entrant in the interest of no one else, releases and discharges the Organising Committee from all present and future claims or liabilities of any kind, known or unknown, arising from participation in the event. Once the registration for " IL CAMMINO TUSCANY CROSSING " has been accepted, the participation fee is non-refundable, but in the event of the event being postponed, transferable to the next edition.

## **RESPONSIBILITY OF THE PARTICIPANT**

The subscriber is responsible for the ownership and safekeeping of his race bib, acquiring the right to use all the services mentioned in these regulations and subsequently communicated. a) Anyone who, without regular registration, takes part without a bib, in addition to being held responsible for damage to

persons or property, including himself, may be liable to the criminal penalties provided for the offence of "theft" (art. 624. criminal code). b) Anyone who, without regular registration, takes part with a counterfeit bib or in any case one that does not comply with the bib allocation, in addition to being held responsible as indicated above, may be liable to the criminal penalties provided for the offence of "theft" (art. 624. criminal code), or alternatively, for the offence of fraud (art. 640 criminal code). In cases a) and b), participants may be liable to the penalties laid down for the offence of "failure to comply with the provisions of the Authorities" (Article 650 of the Criminal Code). The aforementioned cases will also be found after verification of photographic and/or video documentation.

## **DATA PROCESSING REGULATIONS**

Pursuant to Article 13 of the European Data Protection Regulation 2016/679 ("GDPR") we inform: A) that the data contained in the registration form are required for registration, to prepare the list of participants, the eventual ranking, the historical archive, to carry out the services declared in the regulations and to send information material of the Organising Committee ; B) that the consequences of failure to provide the above data or information consist in non-admission to the event; C) At any time the interested party may consult, modify, delete their data free of charge by writing to the person responsible for the processing of personal data the Organising Committee (info@tuscanycrossing.com)

## **LIABILITY AND PROTECTION OF PRIVACY**

By registering for " IL CAMMINO TUSCANY CROSSING " the participant declares that he/she is fully aware of and accepts the present regulations and releases the organisers from all liability, both civil and criminal, for damage to persons and/or things caused by him/her or deriving from him/her. Participants must comply with the rules of the Highway Code. Pursuant to European Regulation 2016/679 on the protection of personal data ("GDPR"), prior to registration the athlete is required to read the documentation on the protection of privacy, available on the website [www.ilcamminodellavaldorcia.it](http://www.ilcamminodellavaldorcia.it) and on the website [www.tuscanycrossing.com](http://www.tuscanycrossing.com) and to express his/her consent to the processing of personal data, in the manner provided. The data provided will be processed in accordance with the provisions of European Regulation 2016/679 on the protection of personal data ("GDPR") and used exclusively for the purposes set out in these regulations.

## **NON-PERFORMANCE**

In the event that the race is cancelled and/or, in any case, not held for reasons not dependent on and/or not attributable to the will of the organisers, including the withdrawal of the authorisation to hold the race by the competent public bodies, the participant shall have no claims against the organising committee or other co-organisers, not even by way of reimbursement of expenses incurred and those to be incurred, the signing of the application form also constituting a waiver of any claim for damages and/or compensation and/or any claim for reinstatement and/or satisfaction of any pecuniary loss suffered and being suffered.

## **VARIATIONS**

The Organising Committee reserves the right to amend these regulations at any time to update any changes that may be made to the UISP regulations or for any other reason it deems appropriate for the improvement of the event.

The organising company reserves the right to vary any clause of these regulations at any time for reasons of force majeure. the race will take place on a mixed asphalt/gravel route. Participants may not in any case tamper with the race bib by concealing inscriptions and/or symbols, under penalty of disqualification. All participants in the race are obliged to comply with the highway code.

It is expressly forbidden to be accompanied by bicycles or other unauthorised personnel.

- specific running/trail shoes with good grip soles
- antiseptic.
- mini first aid kit (including blister plasters)
- Isothermal cover (metalline)
